



## TALKING POINTS ON HOUSE JUDICIARY CHAIR JIM JORDAN:

*MAGA DISCIPLE, TRUMP LOYALIST, ELECTION DENIER,*

*GOBSMACKING HYPOCRITE*

**January 31, 2023**

**Key Point: Jim Jordan has filled the Judiciary committee with conspiracy theorists, insurrectionists, and subpoena dodgers – all to continue to do Donald Trump’s dirty work to damage President Biden and the Democrats to gain more power to impose their radical agenda on Americans.**

- **MAGA Extremist.** Jim Jordan is one of the most far-right extremists in Congress.
  - Jim Jordan (R-OH) has [echoed](#) the extremist and racist Great Replacement conspiracy theory on [several occasions](#).
  - Jordan was [one of the first](#) to endorse QAnon-linked Rep. Marjorie Taylor Greene for re-election.
- **Election Denier.** Jim Jordan is a vocal election denier who continues to push false claims of voter fraud in the 2020 election.
  - Jordan [voted](#) to overturn the 2020 election results.
  - Jordan was a key part of Trump’s scheme to overturn the results of the election on the Capitol and spoke to Trump multiple times on January 6, before and after the attack on the Capitol.
  - Jordan refused a [subpoena](#) from the January 6th Committee to testify about his role and [accused](#) the committee of altering evidence and lying.
  - Rep. Jordan [says](#) he will use investigative power to highlight false claims of voter fraud in the 2020 election.
- **Power Hungry Partisan.** Jim Jordan has repeatedly admitted that he is planning partisan attacks to gain power and weaken Joe Biden.
  - Jordan [admitted](#) that his partisan attacks are designed to “frame up the 2024 race” adding “we need to make sure that [Trump] wins.”

- Rep. Jordan [promised](#) that his House committee will look at “the impeachment question” for President Biden.
- In April, Jordan joined [over 130](#) Republicans in [calling for impeachment proceedings](#) against DHS Secretary Mayorkas after refusing to investigate the very same policies that were used for years by the Trump administration. Jordan has said he intends to impeach Homeland Security Secretary Mayorkas, alleging: “Mayorkas [deserves](#) (impeachment) for sure,” and, “when it comes to looking at an impeachment inquiry, I think Mr. Mayorkas [certainly deserves it](#).”
- Rep. Jordan [claimed](#) he will investigate the COVID-19 response by targeting Anthony Fauci and the CDC. Jordan has [repeatedly echoed](#) disproven [conspiracy theories](#) about the origins of COVID, and the safety and efficacy of vaccines and other mitigation efforts. He has already [contacted](#) dozens of government officials and researchers, requesting documents related to his conspiracies.
- **Hypocrite With No Credibility.** Jordan spent years trying to shield Trump, his family, and his administration from legitimate investigations.
  - Jordan [defended](#) Trump’s hush payments to Stormy Daniels over an alleged affair she had with Trump.
  - Jordan also used his position to try to shield members of the Trump administration [from oversight](#).
  - Jordan turned a blind eye to President Trump and his [family’s foreign entanglements](#) and businesses and Jared Kushner and Ivanka Trump’s [skyrocketing](#) net worth while working for the Trump Administration.
