



REPORT: Rep. David Schweikert and MAGA House Republicans Spent the 118th Congress Pushing the Project 2025 Agenda Instead of Arizonans' Vital Priorities

As the 118th Congress draws to a close, it's clear that the MAGA House Republican majority has been historically ineffective, pursuing the MAGA Project 2025 agenda to do Donald Trump's bidding instead of solving the real issues facing Americans. Polling has consistently shown that Americans are most worried about issues like rising costs, health care, and immigration. Yet MAGA Republicans – including the 17 House Republicans in districts President Biden won in 2020 – have spent their majority crafting bills that would harm investment and consumer spending, damaging the economy while making everyday essentials less affordable.

House Republicans like Rep. David Schweikert (AZ-1) spent the 118th Congress pushing Project 2025, Trump's political agenda, and working up legislation that would take away food aid and Medicaid from tens of millions of Americans, impose restrictions on investing, rip away hundreds of billions of dollars from businesses' climate subsidies, and raise health care costs for over 100 million Americans with pre-existing conditions. Rep. Schweikert and his fellow MAGA House Republicans have spent the past 90 weeks using Congress as an arm of the Trump campaign – all while blatantly ignoring their campaign promises and turning a blind eye to the wishes of their constituents.

David Schweikert And The House Republicans Spent Their Majority Pushing the Project 2025 Agenda. Instead of addressing Americans' vital priorities, House Republicans like David Schweikert are serving as an arm of the Trump campaign, attacking their political enemies and amplifying the MAGA Project 2025 agenda. Ever since they took charge of the House of Representatives in January 2023, Schweikert and his MAGA allies have utterly failed to address the pressing concerns of the American people. The House GOP's voting record – including its most vulnerable members representing the 17 congressional districts that voted for President Biden in 2020 – shows that, instead of addressing these top priorities, MAGA Republicans are choosing to push the Project 2025 agenda through partisan stunts.

Health Care

- H.R. 5376: Voting Against Lower Costs and Better Health Care.** Even before the 118th Congress, Schweikert voted in line with the MAGA Project 2025 agenda to raise costs and make health care less accessible. In August 2022, he [voted](#) against the Inflation Reduction Act, which has lowered health care costs by thousands of dollars annually for millions of Americans by allowing Medicare to negotiate drug prices, issuing inflation rebates for drug company price hikes, ending co-pay cost caps for seniors, and more.
- H.R. 2811: Taking Away Medicaid and Food Aid From Millions of Low-Income Americans.** Schweikert [voted](#) for the Limit, Save, Grow Act, which was [supported](#) by the think tank behind Project 2025 and included proposals to [cut](#) key federal programs and services, block student debt relief, partially repeal the Inflation

Reduction Act, and [take away housing vouchers](#), [food aid](#), and [Medicaid coverage](#) from tens of millions of Americans.

- **The Republican Study Committee Agenda: Pushing Project 2025 and Ripping Away Health Care.** Schweikert currently [serves](#) on the Republican Study Committee (RSC), a far-right policy committee that [includes](#) around 81 percent of the House GOP, all House GOP leaders including Speaker Mike Johnson, and all but four committee chairs. The most recent RSC budget enacts key parts of the Project 2025 playbook related to the economy and health care and would [repeal](#) the Inflation Reduction Act, banning Medicare from negotiating prescription drugs and raising drug prices. The proposal would also end coverage protections for [over 100 million Americans](#) with pre-existing conditions and [transition](#) Medicare to a “Premium Support Model” subsidizing private Medicare Advantage plans, resulting in an [estimated \\$200 billion](#) being wasted on excess payments annually without any improvements in care.

Abortion and Reproductive Health Care

- **H.R. 8296: Refusing To Codify Abortion Protections.** Even before the 118th Congress, Schweikert [voted against](#) codifying *Roe v. Wade*’s abortion protections ([H. R. 8296](#)), paving the way for a wave of extreme and draconian state-level abortion laws in the wake of the MAGA Supreme Court’s ruling. Project 2025 celebrates the end of *Roe v. Wade* and [pushes](#) for further restrictions.
- **H. R. 4368: Banning Mail Delivery of Abortion Medication.** In September 2023, Schweikert supported another [top Project 2025 priority](#): restricting medication abortion. He [voted](#) in favor of [H. R. 4368](#), an appropriations bill that included a rider [repealing](#) an FDA measure allowing abortion medication to be sent to patients by mail.
- **H.R. 26: Voting In Line With the Think Tank Behind Project 2025 on Abortion Provider Restrictions.** In January 2023, Schweikert [voted](#) in favor of [H.R. 26](#), a bill imposing restrictions on reproductive health providers that was [supported](#) by the think tank behind Project 2025 – the Heritage Foundation.
- **H.R. 6914: Voting to Shame and Stigmatize Pregnancy Outcomes.** In January 2024, Schweikert [voted](#) in favor of [H.R. 6914](#), an anti-abortion law seeking to limit students’ reproductive health care decisions just like Project 2025 would. The law pushed anti-choice language designed to [shame and stigmatize](#) people for their pregnancy outcomes.
- **The Republican Study Committee Agenda: Pushing Project 2025’s Mission to Destroy Abortion Access.** The far-right Republican Study Committee (RSC) – which Schweikert currently serves on – is pushing an anti-choice budget proposal that, like Project 2025, would destroy abortion access. The proposal [endorses](#) a total abortion ban without any exceptions, [putting](#) IVF at risk.

Immigration and Border Security

Republicans have been using immigration and border security as a talking point for well over a decade, taking little action to address the situation at the southern border. During the 2022 midterm elections, Schweikert [campaigned heavily](#) on the issue and promised to address it if Republicans won a House majority. They spent millions campaigning on border issues and putting on [elaborate political stunts](#) like sending migrants to Martha's Vineyard to critique policies imposed or exacerbated by the Trump administration – but instead of coming to the table with solutions to help fix our immigration system, Republicans refused to take action and have exploited the crisis for political gain.

- **H.R. 8281: The MAGA Conspiracy-Based SAVE Act.** In July 2024, Schweikert and every member of the Biden-Harris 17 [voted](#) for a dangerous, unnecessary bill fueled by MAGA election conspiracy theories known as [H.R. 8281](#), or the SAVE Act. The bill, which was [supported](#) by the think tank behind Project 2025, would have required documentary proof of American citizenship to register to vote in federal elections – even though a citizenship requirement is already constitutionally mandated – in an effort to promote fear-mongering and push Trump's lies about non-citizen voting. As the Leadership Conference on Civil and Human Rights [concluded](#), “The SAVE Act is both unnecessary and dangerous. Our electoral system already deploys processes to ensure that our elections are secure and that only eligible voters are participating in our democracy. Voters in every state are already required to affirm or verify their citizenship status when registering to vote. State election officials already have in place existing systems to verify an individual's voter eligibility and ensure voter rolls are accurate.”
- **H.R. 7109: Politicizing The Census To Attack Non-Citizens and Pass Unconstitutional Reforms.** In May 2024, Schweikert and every member of the Biden-Harris 17 [voted](#) to bar non-citizens from counting toward Electoral College/congressional district tabulations and to politicize the census by including a citizenship question. The House GOP passed [H.R. 7109](#) 206-202. The bill was [supported](#) by the think tank behind Project 2025 and was labeled a “[voter suppression bill](#)” by pro-democracy groups. The Leadership Conference on Civil and Human Rights [noted](#) that the bill would have violated the 14th Amendment, which requires Congressional apportionment and the Electoral College to be based on “the whole number of persons in each State,” not merely the number of citizens in each state. The bill also would have undermined Census accuracy by reducing response rates.
- **H. Res. 863: Impeaching Homeland Security Secretary Alejandro Mayorkas.** In addition to threatening President Biden with impeachment, MAGA Republicans like David Schweikert also impeached Secretary of Homeland Security Alejandro Mayorkas by passing [H. Res. 863](#). After twice failing to secure enough support, Republicans finally passed the resolution months after introducing articles of impeachment, 214-21. There was bipartisan opposition to the impeachment effort, which was [supported](#) by the think tank behind Project 2025, but in the end, Schweikert and every member of the

Biden-Harris 17 [voted](#) for the MAGA agenda. The Senate [immediately rejected](#) the bogus articles.

- **H.R. 2: The MAGA Border Bill.** In May 2023, Schweikert voted for the MAGA House GOP's extreme, destructive bill known as [H.R. 2](#) – which was [supported](#) by the think tank behind Project 2025 – despite facing bipartisan opposition and concerns from [numerous immigration groups](#). As UnidosUS [noted](#), the bill would have “hurt the economy, do[ne] nothing to address our outdated immigration system or resolve the status of DACA recipients or other undocumented people with deep roots in the United States.” Even though several House Republicans [voted against](#) H.R. 2, Schweikert supported it, and the bill passed 219-213.

Workers and The Economy

- **H.R. 2811: Voting Against Cracking Down on Wealthy and Corporate Tax Cheats.** In April 2023, Schweikert and every member of the Biden-Harris 17 [voted](#) for [H.R. 2811](#), also known as the Limit, Save, Grow Act, which was [supported](#) by the think tank behind Project 2025. The bill, which passed the House 217-215 despite bipartisan opposition, was a proposal to [cut](#) key federal programs and services, including rescinding federal funding for the IRS to go after wealthy and corporate tax cheats.
- **H. J. Res. 98: Voting to Roll Back Labor Protections.** In January 2024, Schweikert [voted](#) in favor of [H. J. Res. 98](#), a bill seeking to [roll back](#) National Labor Relations Board protections for workers with joint employers. The anti-labor Project 2025 would also strip worker protections, [enabling](#) companies to stop paying Americans for their overtime work and [eliminating](#) federal rules that protect children from working in mines, meatpacking plants, and other dangerous workplaces.
- **H.J. Res. 30: Voting to Impose Restrictions on Responsible Investing.** In March 2023, Schweikert and every member of the Biden-Harris 17 [voted](#) in favor of [H.J. Res. 30](#), a joint resolution [supported](#) by the think tank behind Project 2025 nullifying a Labor Department regulation allowing companies to offer investment plans taking into consideration environmental, social, and governance (ESG) metrics. Legislative [analysts](#) and [pension fund managers](#) estimated that legislation punishing financial institutions for using ESG metrics would cost millions or even billions of dollars, harming the economy and reducing investment just to forward the MAGA agenda. The joint resolution was ultimately [vetoed](#) by President Biden.
- **The Republican Study Committee Agenda: Pushing Project 2025's Anti-Worker and Anti-Consumer Agenda.** The far-right Republican Study Committee (RSC) – which Schweikert currently serves on – pushes for anti-consumer and anti-worker policies. The RSC budget proposal [supports eliminating](#) both the National Labor Relations Board and Consumer Financial Protection Bureau just like Project 2025. It also [endorses](#) repealing the corporate minimum tax.

Weaponizing the Federal Government Against Political Opponents

Project 2025 includes proposals to radically reshape the federal government in Trump's image, giving the President far greater control over the executive branch. As part of this, Project 2025 weakens and undermines the independence of the Department of Justice and FBI by allowing political appointees to terminate "major active FBI investigations" at will. Throughout the 118th Congress, MAGA Republicans like Schweikert have worked tirelessly to target federal law enforcement and threaten the independence of the DOJ.

- **H. Res 1292 & 1344: Threatening DOJ Independence By Holding Attorney General Merrick Garland in Contempt of Congress.** In summer 2024, Schweikert [twice voted](#) to hold Attorney General Merrick Garland in contempt of Congress, first voting for [H. Res. 1292](#) to recommend contempt charges and then voting for [H. Res. 1344](#) to hold him in "inherent contempt." This baseless vote to fine the Attorney General – the top law enforcement official in the country – for doing his job, was done [at the behest of Trump](#).
- **The Republican Study Committee Agenda: Pushing Project 2025's Anti-DOJ Agenda.** The far-right Republican Study Committee (RSC) – which Schweikert currently serves on – pushes for defunding DOJ initiatives. The RSC budget proposal [cuts](#) a grant program meant for local police departments administered by the DOJ known as the Community Oriented Policing Services (COPS) program. COPS provides billions of dollars in funding to tens of thousands of police departments across the country.

Education

- **H. Res. 864: Cutting Education Funding For Low-Income Students.** It's no secret that Project 2025 wants to gut the American education system. Project 2025 pushes for universal private school vouchers, privatizing the federal student loan portfolio, and even abolishing the Department of Education entirely. Schweikert has already signaled that he's willing to vote in line with the Project 2025 agenda on education. In November 2023, he [voted](#) in favor of [H. Res. 864](#), an appropriations bill cutting billions of dollars in funding for low-income students. Similarly, Project 2025 would discontinue federal funding for schools serving low-income children.
- **H.R. 5: Voting to Allow Discrimination Against LGBTQ+ Students.** Project 2025 explicitly endorses [H.R. 5](#), the so-called "Parents Bill of Rights Act," which Schweikert [voted](#) for in March 2023. Project 2025 would give school employees [free license](#) to [discriminate against](#) LGBTQ+ students and bar certain students from using school bathrooms and participating in publicly funded athletics programs.
